Re: Recall Petitions - Notice of Insufficiency

Dear Mr. Evans:

This letter is to officially notify yourself and other porponents that the petitions submitted and accepted for filing with this offfice on September 26, 1990, to recall Councilmembers Warnell Coats and Pat Johnson were both found to be insufficient.

City Clerk Stanley Hall elected to use the random sampling technique to verify the signatures on the petitions pursuant to Section 27215 of the Elections Code. The random sampling verification procedure was performed by the County Clerk at our request. The statistical results of this examination are summarized in the attached certification.

Also, be advised that yourself and other proponents are permitted to examine both petitions and ascertain reasons thereof for the disqualification. If you desire to examine the petitions, you must do so no later than 21 days from the date of this letter, or no later than Thursday, November 8, 1990 (Government Code Section 6253.5).
