The Stanford Community Law Clinic operates in cooperation with the Legal Aid Society of San Mateo County, thereby allowing the Clinic to serve a large number of clients in a variety of areas.

The clinic offers weekly intake sessions where clients are given the opportunity to sit down with a law student and describe their legal problems. The Clinic will make every attempt to take cases on for full representation. If the Clinic is unable to take on a case, the client will be referred to the Legal Aid Society of San Mateo County or another appropriate agency.

## OUR STAFF

**PETER REID, *Clinic Director and Attorney at Law***, recently stepped down as Executive Director of the Legal Aid Society of San Mateo County after thirty years of service. ## OUR PROGRAMS

The Stanford Community Law Clinic will focus on three primary service areas:

- **Housing**—The Clinic will provide assistance with disputes over the condition of premises, utility shut-offs, unlawful evictions, and other illegal acts by landlords.
- **Workers' Rights**—The Clinic will assist low-wage workers with a range of employment issues, including wage and hour violations, and unemployment benefits.
- **Government Benefits Advocacy**—The Clinic will offer its services to clients with problems concerning AFDC/CalWORKS, Welfare-to-Work requirements, food stamps, Medi-Cal, SSI, and Social Security.

Additional programs will be offered through the Legal Aid Society of San Mateo County.

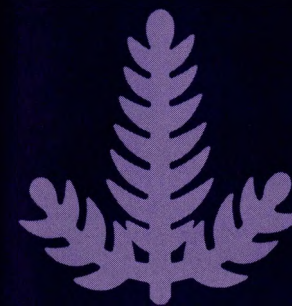
