Much has happened since our last meeting! The survey that was prepared by the Associated Property Owners has been approved by a large majority of the United Homeowners at their meeting on March 6th. The United Homeowners formed an outreach committee to strategize and plan how to reach homeowners in the community with the survey.

The motivation and activity of the United Homeowners Association has triggered a strong opposition from some of the City Council members. Please see enclosed copies of newspaper articles. Furthermore, the opposition, including some City Council members, are in favor of gaining government grants to temporarily solve some of the problems of East Palo Alto. We, as Associated Property Owners, need to oppose a temporary bandage solution for East Palo Alto and ask for a permanent solution which means increasing the tax base.

We urgently need your attendance at our next meeting, Saturday, March 27, 1993 at 10:00 A.M. at 420 French Court, Menlo Park to make decisions on the following agenda.

AGENDA:

- 1. Organize a committee to correspond to our Congresswomen/men, Supervisors, District Attorney, County Manager and others to explain the real problem in East Palo Alto.
- 2. Discuss the opposition to Excise Parcel Taxes.
- 3. Discussion on how to reduce property taxes.
- Discuss possibility of stopping paying all property taxes; consequences and results.
- 5. Organize a committee to investigate the background of the East Palo Alto Law Project, the source of their funding, and write letters to their financial supporters describing the reality of the Law Project's suppression of the East Palo Alto community.
