
Dear Judge Cruikshank:

Through discovery and continuing investigation, contestants have determined that some 121 ballots from the list of 312 filed with the Court on July 29, 1983 will not be challenged. These ballots, a list of which is enclosed, may be dropped from such list, leaving 191 to be challenged, primarily in 3 categories:

- (1) Approximately 55 ballots on the hand-carried list.
- (2) Approximately 91 ballots allegedly obtained by the fraud of Goodwill, Oakes, Blakey or as-yet-unidentified third parties.
- (3) 45 residency challenges.

We hope this information will be helpful in reducing the time required for further discovery, investigation and trial.
