"Sheriff Whitmore's plan for a part-time riot squad in East Palo Alto is a declaration of war on the people and will create new burdens and problems in the community," Glenda Jones, Chairwoman of the East Palo Alto Peace and Freedom Movement, stated today.

The plan proposed by the San Mateo County sheriff would establish a uniformed and armed unit of local residents to serve in "national or emergency" situations.

"A reserve unit under the command of the sheriff rather than volunteers controlled by the people will lead to an increased use of police violence," said Mrs. Jones. "Last summer the volunteer squads organized by the community's Black Community Relations Association were successful in patroling trouble spots and minimizing

outside police harassment." "The sheriff's plan is a direct contradiction of the recommendations of the report released this week by the President's Advisory Commission

on Civil Disorders. The disturbances of last summer in our country were not sparked by isolated incidents of police brutality, but were a direct result of a series of confrontations between police and citizens. There seems to be a Claire Huddleston discussed the recent Wrodside nationwide policy of police chiefs and urban leaders to escalate the use of police and military violence in our black communities in the

coming months," she said. Mrs. Jones, a resident of East Palo Alto and the plan also contradicts the recommendations of East Palo Alto members on a planning committee

for the current Model Cities Grant Application. The committee issued a preliminary report this week charging that "The existing system doesn't work in the community and the need was expressed to change the whole law enforcement system in East Palo Alto. The Sheriff's Department isn't doing the job ... " The committee called for "local control of law enforcement" supervised and supported by the residents.

"In view of this it is arrogant of the sheriff to attempt to impose his will on the community without consultation," Mrs. Jones remarked. "Is this his first move in his campaign for Congress ?"

The Peace and Freedom Club in East Palo Alto has adopted in recent months a platform plank on police-community relations, calling for local hiring and control of officers, a citizens review board, local residence requirement and adoption of a policy that police should not carry lethal weapons on routine patrol.
