We cannot send out a new grant unless we've received the final report for any previous grants. A few organizations have not yet filed final reports for grants received in 1995. If you received a grant from us in 1995 and have not yet sent us your final report, please do so now. If you're not sure, please give me a call. I've enclosed a sheet outlining the information needed in a final report.
