

## Youth United for Community Action

Dear YUCA Family and Friends,

Hello everyone! I wanted to begin by introducing myself. My name is Francisco Preciado and I've been with YUCA as a staff member for over a year and a half now. You may or may not already know, but Youth United for Community Action (YUCA) is a grassroots community organization that is run and led by young people of color which work towards achieving social and environmental justice in our community and beyond. While we are located and grounded in East Palo Alto, our work also extends to the greater Bay Area and most recently with our Youth Environmental Justice Network we are now collaborating with organizations in the Central Valley.


For the last year and a half we have been working intensely to support tenants being threatened with eviction by an unscrupulous landlord. In East Palo Alto, a long standing community member Artemio is being forced to decide whether he should pay an unjust rent increase, buy clothes for his son, or pay essential bills. As a tenant on a fixed income, he asks me, "Why am I being increased an unfair amount? Not only do they want \$150 more, but in all the time I've been here, they've never made one repair. I even had to replace the carpet on my own, so my son could breathe better." This is what's happening in our community; we are fighting to survive. This is one of the countless stories that I've heard and this is why I cannot stop fighting for what is just. Whenever I'm tired from no sleep, being in long meetings, and reading court documents, I remind myself of Artemio's struggle. I know that we cannot remain passive and wait for change to come while our community is being displaced. We must act now!

And acting now is exactly what we are doing. YUCA is currently engaged in three campaigns in our community; environmental justice and accountability, affordable housing and tenant advocacy, and economic justice. In addition to these campaigns we are also engaged in community base building through EPA Link, which brings together community members to discuss issues affecting East Palo Alto. At a regional level we are working with Bay Area and Central Valley organizations to create the first ever Community Toxics Report, which will detail the environmental and health conditions of our communities. And finally at a statewide level, we are connecting with various youth organizing organizations to create a statewide platform that will unite the youth movement with underlying principles of how to achieve social and environmental justice.

In this time of hope for change to build a better tomorrow, we must recognize the work that our young people are doing today. It is this work that will be instrumental in keeping our hope alive. And it is with this understanding that I ask you as my family and friend, to please support with whatever you can give. Whether it is \$5, \$20, \$100, or more, it is all needed in order for us to continue doing this work. If everyone contributes even the smallest amount, we will be able to create a sustainable organization that will harness our young people's passion to build that positive vision for our community, our nation, and our world.

Thank you so much for your time, your contribution, and your support in sustaining our organization.


# WE WILL NOT BE MOVED!!!!!!



"Baja la Renta" (lower the rent) and "3.2 is all we'll do" are chants that are uniting the community of East Palo Alto to fight against illegal rent increases by Woodland Park Management, also known as Page Mill Properties. Tenants like Arnold Hart, Angela Chiprez, Artemio Aboites, and Teresa Salazar have organized together in joining YUCA to implement the 1st of the Month Actions, in which tenants bring attention to their living conditions, personal circumstances, and hardships in their daily lives due to the rent increases. The tenants demand each time that Page Mill Properties hear their concerns, but continue to be ignored by the landlord. Every month there is a new activity that gets more creative each time it is done. Each 1st of the month action has had successful outcomes. One important outcome is the increase in number of tenants that have become involved in both the actions and campaign for affordable housing. As more and more tenants are engaged in this fight for tenant's rights, they are encouraging each other to take action and fight back by filing an individual rent adjustment petition, writing a letter to Page Mill, engaging in rallies, and attending the Tenant Association Meetings to organize against injustices in their homes.

In September and October tenants contronted Page Mill Properties head on in Palo Alto as they entered the double wooden doors requesting to meet with David Taran, the CEO of Page Mill Properties. Page Mill Properties has continuously expressed their willingness to meet tenants and community members, but our phone calls, emails, letters, and personal visits have all gone without response. As we have organized to combat Page Mill Properties unfair treatment of tenants and their families, the Rent Stabilization Board has been a staunch ally for tenants. The Rent Board has made a stance by affirming their belief in rent control. They have made changes to the Rules and Regulations of the Rent Stabilization Ordinance (RSO) to clarify how certificate(s) of maximum legal rent(s) are calculated. Rent for tenants will now be calculated by adding the Annual General Adjustment Rate (AGA) to the lawfully paid rent of the prior year. This will hopefully prevent further rent increases well above the AGA. This year alone tenants have been increased two or three times, yet the living conditions inside their apartments remain the same.

Through our outreach efforts to tenants we have heard the same thing "Why am I being increased so



much when the conditions in my apartment haven't changed at all?" Tenants have also told us that they don't mind paying the allowable legal rent increase, but they cannot afford to pay 20%, 40%, or 60% increases. Tenants have been increased as much as two to three times in the last year and are working hard to make ends meet. To bring to light the issues tenants are faced with, we published a tenant story book, detailing the lives and everyday experiences of families struggling to pay the high rent increases. Their current struggle is not just about affordable housing; it is about fighting for peace, dignity, and respect for people's livelihoods.

# YOUTH ENVIRONMENTAL JUSTICE NETWORK EXPANDS: THE CENTRAL VALLEY CONNECTION



### **CLEAN WATER FOR ALL: AGUA LIMPIA PARA TODOS**

This year in Youth Environmental Justice Network has been all about making connections. This past summer, Bay Area youth from East Palo Alto and San Francisco embarked on a weekend adventure to the Central Valley. Ever since the California Communities Against Toxics (CCAT ) conference in 2007, youth participants in the network were able to connect not only to the issues, but to each other as well. We spent a day with the AGUA youth of the Community Water Center in Visalia and Kids Protecting our Planet (K-POP) in Kettleman City.

At each site, the youth were able see environmental racism beyond their own communities. The youth of AGUA shared their stories and the negative effects of living with toxic water. Even though water is a human right, they are battling with the state and their local government for clean water. It is no coincidence that people are suffering from cancer, skin diseases, blindness, as well as mental health issues at a disproportionate rate in the Central Valley.

At K-POP, youth participated in a dialogue about the issues in Kettleman City with the ChemWaste toxic facility, and also regarding challenges and strengths with working against environmental racism. Youth were able to see similarities in tactics and approaches, as well as responses from the facilities to the communities. The discussion about





a chemical waste facility was not foreign to them because of the experiences in their own communities. We finished the trip back in Visalia where we supported

the Community Water Center with a press conference. This press conference was organized to give further exposure to the water issues in the Central Valley as well as to pressure the Governor to sign two bills that would help with the issues. YEJ youth spoke on camera as well as led chants at this event!

We are very excited to say that was only part one of the gathering exchange. At the end of October, Central Vallev youth came up to the Bay Area and we were able to share our communities with them! Not only did we examine the issues in our communities, but we engaged in team-builder exercises, came up with a concrete plan to continuously communicate with each other, and finalized the plan for the Community Toxics Report! The Community Toxics Report will identify the environmental and health conditions of our communities. **NO ON PROP 6!** (UCA joined forces with our brothers and sisters in the South Bay/San Jose area in order to come up with a collective strategy in order to defeat Proposition 6. This proposition would have tried youth as young as 14 as adults, expand "gang-related" felonies and lengthen sentences, deny bail to undocumented immigrants charged with certain felonies, and force entire families out of Section 8 housing if a background check was not passed. It would have also taken away billions of dollars from the much needed funding that goes towards education, health, and California's social services. We organized grassroots style through text messages, myspace, rallies, canvassing, registering people to vote, and going door to door in order to let people know that this proposition needed to be defeated. And on Novemper 4th, Prop 6 was defeated by a landslide!

# **Keeping An Eve On Romic**

The CAG is a group of community members from East Palo Alto, that is not resting until every inch of soil and every drop of groundwater beneath ROMIC is cleaned. YUCA started the CAG in order to oversee the USEPA as it attempts to clean up the contaminated Romic site. The CAG is a project of YUCA



and the Environmental Justice Group (EJG) intended to provide a community voice to the cleanup phase of the closed facility. YUCA members have been reaching out to community members from around the town to finish the process of cleaning up after

After long deliberation, on July 28th the USEPA finally decided on it's remedy plan for the ROMIC site. They settled on a remedy called cheese, whey and molasses; a mixture that they will inject into the ground causing the breakdown of toxic chemicals. In order to oversee this process, the CAG will be researching these methods, reading project status reports and communicating with the USEPA. The CAG is still recruiting community members committed to holding ROMIC accountable and protecting our community health. At YUCA we know that it's not over until Romic is a thorougly remediated site. Until that happens, we will continue to keep an eye on Romic.
