THIS LETTER IS TO DOCUMENT THE COMPLAINTS, WHICH I MADE TO YOU ON WEDNESDAY, NOVEMBER 21, 1984 AT YOUR MEETING.

FOR THE PAST YEAR THE FOLLOWING HAS OCCURED AT THE ABOVE ADRESSES. WITH NO ATTEMPT BY THE SHERRIF'S DEPT. TO STOP THEM, ALTHOUGH I, AND VARIOUS NEIGHBORS HAVE CALLED AND REPORTED THEM.

1. IT IS COMMON FOR VARIOUS MALES FROM THESE TWO HOUSES, TO BE WALKING BETWEEN HOUSES, TO VEHICLES, OR LOUNGING IN THE AREA WITH HAND-GUNS STUCK DOWN IN THE FRONT OF THEIR PANTS.
 2. ON NUMEROUS OCCAISIONS DAY OR NIGHT, MALES WHO ARE LIVING IN ONE OF THE HOUSES OR VISITING WILL JUST STEP OUT ON THE FRONT PORCH, AND URINATE IN THE YARD IN OPEN VIEW OF EVERY AND OR ANYONE.
 3. RECENTLY ON A SATURDAY NIGHT EARLY NOV. 1984; A MEXICAN MAN WAS NAKED IN THE FRONT YARD THROWING UP, AND DRINKING OUT OF THE OUTDOOR WATER HOSE.
 4. MY FRONT WINDOWS WERE BROKEN AND CRACKED BY BEE BEE SHOTS FIRED FROM ONE OF THE HOUSES? "WHO KNOWS" ONE NIGHT WHILE SLEEPING UPSTAIRS A BIG ROCK CAME THROUGH MY BEDROOM WINDOW I CALLED THE SHERRIFF'S DEPT. AT THAT TIME AND THEN AGAIN ABOUT 30 MINS LATER THEY WERE SENDING SOMEONE. THAT SOMEONE I FELL ASLEEP WAITING FOR.
 5. MY FENCE HAS BEEN KNOCKED DOWN AT LEAST 3 TIMES, BY EITHER PEOPLE TRYING TO PARK WHILE INTOXICATED, BACKED INTO, AND RAN DIRECTLY INTO. THE CALIF. HIGHWAY PATROL WAS CALLED EACH TIME.
 6. THERE MAY BE AS MANY AS 10 CARS PARKED AT EACH HOUSE AT ANY ONE TIME.
 7. GOATS ARE BEING SLAUGHTERED IN THE BACK YARD ON A REGULAR BASIS.

8. BEHAVIOR INDICATES DRUG TRAFFICING IS GOING ON, I HAVE ALSO REPORTED MY SUSPICIONS TO THE S.M. COUNTY SHERRIFF'S DEPT.
- CARS ARE CONSTANTLY COMING AND GOING OF ALL MAKES AND PEOPLE OF ALL RACES.
 - THE EXCHANGING OF SOMTHING WITH SOMEONE IN THE CAR THN THE CAR DRIVES OFF.
 - CAR HORNS BLOW ALL TIMES OF THE NIGHT.
 - HAVING GUNS ON AND ABOUT THEM.
9. IN ADDITION ONE OF THESE MEN BROKE IN ON MY NEIGHBOR WHO LIVES ALONE, LUCKY FOR HER, SHE HAS A GREAT DANE DOG THAT IS NOT VERY FRIENDLY; WHICH MADE THIS MAN FLEE QUICKLY.
10. LAST BUT NOT AT ALL LEAST; ON NOV. 7, 1984 ON A WEDNESDAY EARLY AFTERNOON, MY LITTLE NINE YEAR OLD GIRL WAS SEXUALLY ASSAULTED BY A MEXICAN MAN AT THE 2360 ADDRESS DIRECTLY ACROSS THE STREET FROM MY HOUSE. HE WAS LIVING IN THE BACK IN A SHED, HE HAD BUILT FOR 'HE' AND HIS WIFE'S DWELLINGS, WHICH I DON'T THINK IS LEGAL TO DO.

I BELIEVE THAT THESE TWO RESIDENTS SHOULD HAVE BEEN CHECKED OUT MONTHS AGO, BEFORE THIS MAN THOUGHT HE WAS COMFORTABLE ENOUGH TO COMMIT SUCH A DISCUSTING, LOW, HURTING & NON FORGETTING CRIME.

I WOULD SUGGEST THAT YOU REQUEST THE RECARD OF THE COMPLAINTS ON THESE TWO PREMISES, FROM THE SAN MATEO COUNTY, SHERRIFF'S DEPT.

YOU SHOULD ALSO KNOW THAT IT IS ALMOST IMPOSSIBLE TO KNOW IF ANY ONE PERSON AND OR FAMILY LIVES IN EITHER HOUSE THE TURN OVER OF PEOPLE AND FAMILIES IS REMARKABLE. SO THEREFORE WE DONT' KNOW WHO OUR NEIGHBORS ARE.

IN CLOSING I'M GETTING SIGNATURES FROM CONCERNED AND BOTHERED NEIGHBORS.
