Dear Mr. Somerville:

Please accept this as our final report on Raíces de México's "Dia de Los Muertos" weeklong event.

The festivities started on October 26, 1996 at Green Oaks School in East Palo Alto and at the Manor House at Twin Pines Park in Belmont. At Green Oaks we had a variety of hands-on workshops geared toward families. All the workshops made something related to the "Day of the Dead" such as paper skeletons, clay skulls, decorations for the altar which was setup in one of the classrooms, and paper masks.

The week before the children were asked to paint, draw, color something that they thought was related to that day. The multipurpose room was full of childrens' entries and certificates were awarded to the best interpretations.

Musicians came and played traditional songs and there was a performance by the childrens' and teens' class as well as the performing group of Raices de México. The turnout was moderate; teachers and parents helped in the workshops.

Meanwhile at the Manor House, art from eight local artists was exhibited in the gallery which opened to the public at 12:00 noon Oct 26. Ramon Morones created a very traditional altar complete with incense, food, skulls, candles, flowers and pictures of bygone friends/family. Another altar was created in and on the mantel of the gallery fireplace by another artist, Teresa Bravo.

On Wednesday, Oct 30, another hands-on workshop was offered for children and parents at the Manor House. At this workshop corn husk angels, masks, and potatoe stamp paintings were made.

On Saturday, Nov 02, was the closing ceremonies at Manor House which entailed a reception, showing of the documentary film "The Day of the Dead", by Susan Muñoz and Lourde Portillo, appetizers and entertainment by live musicians.

The collaboration with the Arts Council for this event worked well, only disappointment was that internal strife among the staff resulted in a part of the printed flyer being mailed out late and half a box full of flyers not mailed out at all. This box was discovered Oct 30 in the back of the office, and we are sure contributed to the moderate turnout. Also letters requesting donations for appetizers were not sent out until two weeks before the event.

Enclosed are pictures that were taken at Green Oaks and some from the workshop on Oct 30. We will send in rest of pictures as soon as they are received.

We are very grateful to Philanthropic Ventures for having awarded Raíces de México moneies to help defray some of the costs of this event. It was a successful first endeavor which we plan to repeat again in 1997.
