

RENT CONTROL IS DEAD UNLESS YOU ELECT BARBARA MOUTON AND SHARIFA WILSON TO THE EPA CITY COUNCIL ON NOVEMBER 6

OF THE CANDIDATES RUNNING, ONLY BARBARA MOUTON AND SHARIFA WILSON HAVE ACTIVELY DEFENDED RENT CONTROL AGAINST THE ABSENTEE LANDLORDS WHO WORK TO DESTROY RENT CONTROL AND AFFORDABLE RENTAL HOUSING. BARBARA MOUTON VOTED TO INTRODUCE RENT CONTROL TO EPA AS THE FIRST MAYOR OF EAST PALO ALTO IN 1983. SHARIFA WILSON HAS FOUGHT THE ATTEMPTS OF THE CITY COUNCIL MAJORITY (BOSTIC, COATS, AND JOHNSON) TO DESTROY RENT CONTROL. AS A RENTER AND A SINGLE PARENT, SHE KNOWS THAT THOUSANDS OF OTHER SINGLE PARENTS AND LOW AND MODERATE INCOME WORKING PEOPLE CANNOT KEEP A ROOF OVER THEIR FAMILIES WITHOUT RENT CONTROL. HOMELESSNESS HAS INCREASED 50% IN SAN MATEO COUNTY IN THE PAST 4 YEARS BECAUSE OF LACK OF RENT CONTROL OUTSIDE OF EAST PALO ALTO. THE LANDLORDS ARE PLANNING THE DESTRUCTION OF RENT CONTROL BEGINNING WITH THE FIRST RENT BOARD MEETING ON NOVEMBER 13 RIGHT AFTER THE ELECTION IF BARBARA MOUTON AND SHARIFA WILSON ARE NOT ELECTED!

BARBARA MOUTON AND SHARIFA WILSON WILL STOP LEGALIZED GAMBLING FROM TAKING OVER EAST PALO ALTO IF ELECTED

THE PRESENT CITY COUNCIL MAJORITY (BOSTIC, COATS, AND JOHNSON) HAVE VOTED TWICE BY CONSENSUS TO STUDY THE ADVANTAGES OF BUILDING THE LARGEST LEGALIZED GAMBLING CASINO IN NORTHERN CALIFORNIA HERE IN EAST PALO ALTO! WITH LEGALIZED GAMBLING COME GREATLY INCREASED CRIME, PROSTITUTION, DRUGS, AND CORRUPTION OF PUBLIC OFFICIALS BY ORGANIZED CRIME. HOME PROPERTY VALUES WOULD COLLAPSE. WHO WOULD WANT TO RAISE THEIR FAMILY IN A CITY CONTROLLED BY THE MAFIA? A NEW CITY COUNCIL MAJORITY (MOUTON, MAYOR VINES, AND WILSON) WOULD END THE INSANITY WITH A NO VOTE AGAINST LEGALIZED GAMBLING.

THE CURRENT MAJORITY (BOSTIC, COATS, AND JOHNSON) DEFIED THE WILL OF THE PEOPLE EXPRESSED THROUGH A PETITION WITH NEARLY 400 SIGNATURES AND AT A PUBLIC HEARING TO HAVE AN ENVIRONMENTAL IMPACT REPORT TO STUDY THE POTENTIAL HEALTH HAZARDS AT THE ROMIC CHEMICAL CORPORATION. THEY TURNED DOWN THAT REQUEST TO LET THE PEOPLE KNOW THE DANGER FROM TOXIC WASTES TO THEM AND THEIR CHILDREN. MOUTON, WILSON, AND VINES WILL VOTE TO PROTECT YOU AND YOUR CHILDREN BY SEEING TO IT THAT YOU KNOW THE TRUTH ABOUT THE DANGERS FROM HAZARDOUS WASTES IN EAST PALO ALTO, THE HAZARDOUS WASTE DUMPING GROUND OF SAN MATEO COUNTY.

MOUTON AND WILSON WILL WORK TO ESTABLISH CHILD CARE CENTERS FOR WORKING MOTHERS

MOUTON AND WILSON WILL WORK WITH MAYOR VINES AS THE NEW CITY COUNCIL MAJORITY TO ESTABLISH LOW-COST CHILD CARE CENTERS FOR EAST PALO ALTO RESIDENTS SO THAT MOTHERS WILL HAVE MORE MONEY TO FEED, CLOTHE, AND HOUSE THEIR CHILDREN.

MOUTON AND WILSON ALSO RECOMMEND THE ELECTION TO THE RAVENSWOOD SCHOOL BOARD OF RUBEN ABRICA, BOMANI SIWATU, AND MYRTLE WALKER

ABRICA, SIWATU, AND WALKER TOGETHER WITH DONNA RUTHERFORD AS THE NEW MAJORITY ON THE SCHOOL BOARD OF TRUSTEES WILL SEE TO IT THAT SCHOOL ADMINISTRATORS ARE HELD ACCOUNTABLE FOR RAISING TEST SCORES.
