

BREAKING THE CHAINS....

Activity behind the Incorporation scenes grows frantic. LAFCo's executive officer, who opposes the Incorporation of EPA, and is giving both EPACCI and LAFCo false information, has come up with all kinds of "new" requirements to stall the Incorporation vote. He has even gone so far as to blame other County departments for his failure to produce the reports required by his office.

But EPACCI will not be moved from its determination to incorporate East Palo Alto. Our group has thus far collected and submitted all of the reports required for LAFCo. We have made a responsible request for a November election. We have cooperated fully with the County despite the misrepresentations by the LAFCo executive officer and the misleading stories in the Peninsula Times-Tribune.

All of the local press coverage in the Times is focusing on attempts to delay the Incorporation vote; the paper deliberately headlines the false information provided by the LAFCo staff. East Palo Altoans demand an Incorporation vote and are not fooled by the collusion between LAFCo staff and the Times-Tribune.

Basic information on EPA's capacity to start a new city is absolutely favorable. Stanford Research Institute International (SRI) concludes that Incorporation is fiscally and administratively feasible and the best possible option for EPA. A recently completed study by Recht, Hausrath and Associates, commissioned by the San Mateo County Board of Supervisors, concludes that any new land development in EPA would be beneficial regardless of whether it is residential or commercial. Staff in the County Manager's Office have also concluded that Incorporation is financially feasible.

The residents of EPA recognize the the LAFCo executive director's stall for what it is. A deliberate delay in the Incorporation vote will allow the County and others with vested interests to put into place their plans for making EPA an additional bedroom community for the Peninsula—a very simple solution really for the current job and housing imbalance problems beleaguring San Mateo and Santa Clara Counties.

More and more of us must step forward and be counted in the Incorporation Movement. BREAK THE CHAINS THAT BIND—County, NO; City, YES. Do your part in making history: Buy an Incorporation T—Shirt, stick on an EPACCI bumper strip, xerox this article and pass it on.

It is once again time to salute a familiar face in East Palo Alto.

One man who has worked untiringly for many years with our kids, with little regard for fanfare or awards, is East Palo Altoan Chester Prince. As a resident of the community for the past twenty years, Chester, who lives with his family over in University Village, has devoted much of his spare time to studying the bible, while reserving the remainder of his energies for the local 4-H clubs.

During his twelve years with the Cooperative Extension of the University of California's Agricultural Department, Chester has stimulated the interest of many local youngsters, ranging in age from 9 to 19, in animal husbandry and farming. In recruiting these youngsters to 4-H projects and the like, he has shared some of the old-fashioned farm skills learned in his native Beaumont, Texas.

Chester, who believes that our youth can do much to turn EPA around so that it can become a wonderful place to live, recalls one fond memory of EPA's first 4-H entry into the San Mateo County Fair Livestock Show back in 1971. "It was the first time we had young people from EPA participating at that level at the County Fair. One of our kids, Wilford Brooks, did extremely well exhibiting his steer and was a real inspiration to the other 4-H'ers. Another year, we nearly took a 'Reserved Grand Champion' Ribbon; and, at the end of the Fair, our entry darn near won top bidding dollar at the subsequent auction."

The premier "Facts on Incorporation" pamphlet is a testimony to the competence and dedication of EPACCI volunteers. This cogent and timely work, sent to all registered EPA voters, was specifically designed to simply explain all aspects of the Incorporation process. In crisp, clear language, inquiries raised by East Palo Altoans, ranging from concerns about the projected cost of cityhood, to the very kinds of city services that will be offered, are answered.

Readers can look forward to the second pamphlet, being prepared by our SRI consultants, sometime in early May. The more technical phases of Incorporation will be the focus.

SUB-COMMITTEES REPORT. .

ATTENTION: Attendance at EPACCI Meetings is on the upsurge again. Vital input needed to keep our many committees active requires each of us to participate in some way. If you have not yet joined a committee, or have taken a break from the one on which you served, and have a little time to spare, please come to our next general meeting. They're still held on Tuesday Evenings, 7:00 p.m., EPA Muni Council Building.

Sub-Committees have merged and/or modified their names in same instances. Incorporation Application remains unchanged; however, the Education and Voter Registration Committees have combined to the form the Community Mobilization Committee; the Publicity Committee is now known as Public Information; and Fundraising has additionally undertaken the chore of promoting EPACCI souvenirs.

Incorporation Application Committee has determined that obtaining the approval from LAFCo and the Board of Supervisors will be their #l priority in the summer ahead. They will be identifying community groups and public officials to solicit their support, and they will be following the Incorporation Application as it is processed by the County.

Community Mobilization Committee plans to further organize the Outreach Network by identifying and training block, street and precinct captains. They will also be doing community mobilization work by developing, distributing, tabulating and analyzing an Incorporation questionnaire. The Committee also anticipates identifying all unregistered residents of EPA, placing their locations on a pin map, and then recruiting volunteers to develop a workable and implementable voter reg strategy. Their goal is to register 10-to-12,000 residents before the election on Incorporation.

Public Information Committee will continue its charge to inform the community through production of EPACCI souvenirs, publications, news releases, posters, and creative visual and audio mediums; including some skywriting and a mobile van. Further utilization of the media will involve setting up booths for special celebrations such as Cinco de Mayo, Juneteenth, July 4th, and blitzing the news networks the month preceding the Incorporation vote.

Fundraising Committee, who invariably have the toughest job of all, will be producing some grand fundraising ideas, but solicits your immediate input in this undertaking. Fundraising will now include foundation contacts, solicitations, sponsoring various events, and the sale of souvenirs.

THE BANNER FLIES AGAIN

Thanks to the efforts of the EPACCI members and the cooperation of P.G.&E. and the Menlo Park Fire District, our Incorporation Banner is waving over University Avenue once more. It is a daily reminder to all of us that the efforts towards Incorporation and city government continue as strongly as ever.
