INTEREST ON SECURITY DEPOSITS

As of April 27, 1984, all deposits (cleaning, security, and last month's rent, etc.) must be placed in an interest bearing account at a savings and loan association or bank. The interest earned on said deposit monies shall be returned to the tenant annually either through a rent rebate or a cash payment. The balance of any interest earned by said payment or deposit monies shall be returned along with the appropriate part of principal to the tenant upon his/her departure from the premises.

What can tenants do if the landlord doesn't return interest on security deposits?

• The first step is to notify your landlord of the situation to seek voluntary compliance.

• The second step is to call the Rent Stabilization Program for counseling on remedies offered under the Rent Stabilization Ordinance.

What if my landlord doesn't return my security deposit after moving?

This is a frequent question asked by former tenants. The Rent Stabilization Ordinance does not porvide any remedies for this specific situation. One option for tenants is to file against the landlord in a small claims court. For information about Small
